

## **INFORMATION On holding direct sales for the realization of 100 percent of government shares of Closed-Joint stock company “Alfa Telecom”**

### **State Property Management Fund**

under the Government of the Kyrgyz Republic

**informs about the realization of 100 percent of government shares of Closed-Joint stock company “Alfa Telecom” - 100,100 (one hundred thousand and one hundred) shares (hereinafter referred to as CJSC “Alfa Telecom”)**

Owner of the selling property – The Kyrgyz Republic

Means of payment - national currency of the Kyrgyz Republic “som”.

Applicants should provide price offer on purchase of 100 (one hundred) percent of shared of closed joint-stock company “Alfa Telecom” **not below the amount of 13 500 000 000 (thirteen billion five hundred million) som.**

According to the legislation of the Kyrgyz Republic, when privatizing state property, the seller (represented by the State property management fund under the government of the Kyrgyz Republic) charges a **commission fee of 7 percent over the selling price.**

2. Letter of attorney certified according to Kyrgyz Law, in the name of the applicant, authorizing the person acting on behalf of legal entity to make transactions as needed;
3. Copy of constituent documents certified according to Kyrgyz Law;
4. Copy of notarial certified State Registration Certificate according to Kyrgyz Law;
5. Certificate on not being in debts on tax obligations and payments to Social Fund of the Kyrgyz Republic. This requirement isn't obligatory for foreign applicant who is non- resident of the Kyrgyz Republic;

7. Signed list of all provided documents in 2 copies.
